Ethical Trading Policy

Standards:

- Working conditions are safe and hygienic.
- Child labour shall never be used.
- Living wages are paid; wages should always meet basic needs and provide some discretionary income.
- Working hours are not excessive.
- No discrimination is practiced.
- Regular employment is provided.
- No harsh or inhumane treatment is allowed.

Commitments:

The Company is committed to implementing and maintaining labour standards by:

- Promoting good labour standards and ensuring that it is utilising an ethical supply chain for its products and services. .
- Bring awareness of fair and ethical trading to company employees, as well as to customers and suppliers.
- Maintaining a reputation as a supplier of ethically traded products and services.
- Ensuring that both the Company and its suppliers adhere to current and future local, national, and global ethical trading legislation.
- Monitoring business endeavours to ensure that all its business activities are within the scope of the Ethical Trading Initiative.
- Ensuring that there is no modern slavery or human trafficking in its supply chain or in any part of its business
